TEACHING METHODOLOGY

Unit 1: What is Animated Documentary?

Description:

This unit picks apart the essentials of animation and how they correspond to the study, analysis, and creation of documentary. The discussion will shed light on the complexities of documentary, evidence, and realism in an era of post-truth.

Unit 2: The History of Animated Documentary

Description:

When did animated documentaries begin and why? What is the relation between animated documentary and "useful animation" since the early 20th century? This unit will include a discussion of diverse visual fields (ranging from education, science, journalism, advertising and more), techniques and materials.

Unit 3: Animated Documentary in the 21st Century

Description:

Why has the field of animated documentaries proliferated in the 21st century, and how does this relate to digital screen culture? Which new technologies and cultures (such as gaming, VR, AR and AI) merge into the field of animation, and how do new techniques influence the epistemology of animated documentaries?

Unit 4: Creating an Animated Documentary

Description:

Implementing ideas covered in the other units of study, the practice of animated documentary includes the analysis and creation of elements of animated documentary from a narrative, script, visual and marketing perspective, considering the advantages, challenges, philosophy and ethics of creating an animated documentary work.
